Motion to accept minutes, motion was accepted.

Treasurer's Report

Checking a/c balance: \$1,123 Savings a/c balance: \$147,504

Total outstanding dues are \$25,284. The balance is comprised of 16 accounts; 3 of which are in collections. Two additional accounts are being sent to collections. At this time last year, the outstanding balance was \$23,968 and was comprised of 19 accounts.

Motion to accept Treasurer's report, motion was accepted.

Motion was made to authorize the Treasurer to notify late accounts that they are going to Small Claims Court if not paid by due date in January. Motion was accepted.

Old Business

- o Chip Johnson came to the meeting to explain his intentions to be compliant, Greg asked for Chip to provide the status in an eMail, or a letter so that there is a paper record.
- A motion was made regarding contacting Edward Cahill about C&R violation.

Delinquent Accounts- Status

o Kathy Johnson - Last meeting placing a lien was authorized, The Treasurer received the full amount the day after the last meeting so there was no need to place a lien.

• Ira's Lane Access and Sign on Old Mill Road

Concrete blocks costs approximately \$55. NH corrections indicated that a black and white sign that says "Private Road, Residents Only" 18" x 24" including hardware (pole, mounting bracket etc.) costs \$42.

A 24" diamond black on yellow "No Outlet" sign for the entrance to Windsock Village on Old Mill Road, costs \$55. A discussion took place regarding the location for the sign. Bob Pustell suggested a 12ft pole vs 10ft pole so it can hold two signs.

A motion was made to purchase 2 concrete blocks, and to purchase the two signs, motion was accepted.

Tom Huckman is going to push snow to block the road for now, and put back the boulders that he had previously used.

New Business

Snowmobiles - Use of Roads and Taxiways

Discussion took place about how Snowmobile access to the trail may be lost via Ira's Lane when the road is blocked, as the owners of Ira's Lane may decide to close it to Windsock residents, as it is a private road. Tom Huckman has blocked off his property to snowmobiles due to inconsiderate use of the property.

• Signage - Corner of Old Mill Road and Red Baron Road

An email was received from Christy Pacheco regarding her concerns about Red Baron and Old Mill Roads with people cutting the corner, and almost hitting pedestrians. A suggestion for an additional sign was made by Christy, and she offered to design a fun sign that would get attention. A discussion took place regarding the number of signs already there. A motion was made that no action be taken at this time. Motion was accepted. Note - if Ms Pacheco brings a proposed sign design to the Board we would review it but for now the Board feels that the current signage is about the best we can do without creating sign overload or clutter.

Public Comment

 Discussion ensued regarding the equipment that the plowing contractor is currently using to plow our roadways. A yellow loader with a plow on it is being used to make the first pass and then the plow truck is coming in next to plow back the sides of the roads. Greg will have a discussion with the plowing contractor to ensure the most efficient use of equipment and labor.
