#### **Old Business**

• Delinquent Accounts- Status

- Steven Brown required by the Court to make monthly payments for \$250 from March 1st until judgement is paid off. So if he hasn't paid by the end of the month, we inform the court.
- WVPOC Budget
  - Budget vs actual, plowing significantly higher than what we had budgeted. Currently at \$28,000 through February. Maureen Brooke's said, this year vs previous years is running about 20% above average of earlier years. Greg is thinking future years, budget \$28,000 per year vs \$20,000 for plowing.
  - Greg didn't see any other line items that he felt needed to be increased.
  - Greg will put something together regarding specific needs for maintenance like mowing, cleanup etc. so he can obtain estimates.
- WVPOC Policy Development
  - Paula sent out a first pass at some policies, looking for input from others.
  - Some items discussed were:
    - What constitutes a commercial vehicle?
    - Are snowmobile, motorcycle and ATV trailers acceptable?
  - Public input Some felt that the big green structures for storing RVs shouldn't be acceptable.
  - Storage trailers, example pods. For temporary use storage. Remove in open view.
  - Greg believes a compliance section is required.
- Interest expense line item question from February meeting.
  - Is approximately half of what was to be paid this year on this note for the road improvement. Still not sure why it's a separate line item. David has been asked for exact details on what is interest and principal.

• 2019 Annual Meeting - Was discussed, the date is June 8th - the location is Chuck Waldo's property, 20 Navajo Way. WVPOC will be in the morning.
