#### **Old Business**

- C&R Violations

  - 8 Red Baron Road- Cahill we are still waiting on the court.
  - 24 Captains Way- Eric Diaz- still ongoing
  - 31 Navajo Trail- Chris Downing- building setback issue still ongoing
  - 53 Old Mill Road Mark Thurell, brush piles ongoing. Has contacted someone to get it removed.

- 11 Old Mill Road, Lee's, ongoing with regard to container, have been informed it will remove by February.
- Chip Johnson referred to a house with fallen fences at the end of Skyhawk Drive. Carl mentioned the aviation board normally contacts them as it involves the taxiway.
- Delinquent Accounts
  - 11 people owe the full assessment and there are 8 that owe partial assessments. Two people have paid, but have not paid their outstanding interest. A letter will be sent in January reminding people they will go to small claims if unpaid.
